- Participants will carry out the education course with microphones turned off; there will be no speeches, except for a 10-minute question time at the end of each lecture and after booking on the platform chat.
- There will be no roll-call or checks on the actual participation of the participants.

## FINAL TEST

- Attached to this notice there are the files containing the same alphanumeric codes as those assigned to competitors before the first phase;
- The organisation will use the platform: **Zoom**;



- The desk must be structured in such a way as to be fully visible via webcam; the candidates will take their places in a dedicated classroom, each at a distance of at least one desk from the other, making the entire desk surface visible.
- In order to access the platform, each participant must use the Institute's e-mail address or his own (at his discretion), using the alphanumeric code assigned as his username.
- **Each participant will be provided with 6 numbered sheets, marked only with the alphanumeric code; these sheets must be printed and the test will be carried out on them - and only on them; under no circumstances may the name of the participant or any other identifying mark (including stamps, protocols, signatures) appear on the work sheet, under penalty of exclusion.**
- At 09.00 a.m. on 22 May 2021 - Italian time - the participant must be connected to the platform, via the link and show, at the request of the remote supervisor, a valid identification document.
- At the end of the identification process, upon indication by the remote supervisor, the participant will deactivate the incoming audio and activate the outgoing audio; the track will be transmitted on the room chat only at the end of the identification procedures; from that moment on, the 3 hours will start running.
- At the end of the 3 hours, a deadline indicated by the remote control, the competitor must cease all writing activity, under penalty of disqualification. The teacher in charge must take a photo of the pages (fair and rough pages) of each student's test with his or her mobile phone and send it via Whatsapp, within 5 minutes of the end of the test.
- The pages not used must be cancelled, photographed and sent via whatsapp in the same way as those used.
- In the 30 minutes following the transmission of the images via whatsapp, the scans of the individual test, renamed with the alphanumeric code assigned to the participant, must be sent to the e-mail address.
- It is specified that the tests of each competitor must be contained in a single .pdf file named with the matching alphanumeric code; if an Institute has enrolled more than one student, it will send the tests as an annex to a single email.
- If the internal teacher needs to report any problems or criticalities to the organization, he/she should send a whatsapp message to no. containing the following information:
  - Room number;
  - Name of the candidate;
  - A concise description of the problem encountered.
- Please note that in no case is it permitted to leave the classroom, under penalty of disqualification, and that, equally under penalty of disqualification, the use of mobile phones, smart-watches and other electronic devices is not permitted.
